Biographical Note

Joseph Peter Spang III (1934-2020), known as Peter, spent most of his adult life in the preservation and study of history, architecture, arts and landscape of Deerfield. After graduating from Harvard in 1956 with a degree in history, Peter went on to do graduate work in the arts and material culture in London and Virginia. He came to work for Henry and Helen Flynt in 1959 at the Heritage Foundation (now Historic Deerfield), and spent the rest of his professional career there. Peter was the first professionally trained employee of the Flynts and later became known as the founding curator. After retiring from Historic Deerfield in 1986, Peter went on to become a Trustee until his death in 2020. From 1959 until his death in 2020, Peter's primary residence was on the "The Street," first living in the Sheldon House apartment and then purchasing Lot 1 West at the North end of the street.

In addition to his devotion to Historic Deerfield, Peter also found time to serve on many governing boards and committees of historical agencies all over New England and beyond. Among his many appointments are the Massachusetts Historical Society, Historic New England, the Lewis Walpole Library of Yale University, Strawbery Banke, Edith Wharton Restoration, The Trustees of Reservations, the Austin house of the Wadsworth Athenaeum, the Concord Museum, Old Sturbridge Village, the Juliette Gordon Low Birthplace, the Attingham Trust, the Essex Institute, Deerfield Land Trust, Pocumtuck Valley Memorial Association and the Franklin Land Trust. The Walpole Society was another group that Peter took great pride in being part of. He closely documented his time with his Walpole friends and greatly looked forward to their outings.

Organization of the Collection

The majority of the collection came to Historic Deerfield through the estate of Peter Spang. Some material, mostly relating to his work at Historic Deerfield, was already in the library and the two sets were added to form this collection. The majority of the papers from the estate came to the library in 2023.

This collection deals primarily with Peter's relationship to Historic Deerfield and town of Deerfield. Material relating to the different organizations he was involved with are not part of this collection and should be sought from these organizations own records. As so much of Peter's life was about Deerfield, it is often hard to separate business and personal papers in this collection. While there are separate categories of Business Correspondence and Personal Correspondence, the two often merge as many business acquaintances became friends, and many of his friends became involved in his professional life. When searching his correspondence, it is best to search both his business and personal letters for items. There is a limited amount of material present in the collection related to Peter's time as a Trustee of Historic Deerfield since all of the Trustee Meetings are already archived at Historic Deerfield. The Trustee papers focus

on Peter's involvement with capital campaigns and various issues and correspondence not represented in existing Trustee records.

Related Collections

For many years before his death Peter contributed many items to the Heritage Foundation and Historic Deerfield Archives. In addition, much of the material from his estate was incorporated into the existing Archives. For more information of the history of Historic Deerfield see **Heritage Foundation Archives**, **Historic Deerfield Archives**, and **Historic Deerfield Summer Fellowship Archives**.
